Investment objective

Aim

This fund aims to deliver above inflation growth, whilst taking a medium level of investment risk relative to the other funds in the Governed Portfolio range. Investment risk is a measure of the expected volatility. On a scale rating the investment risk of Governed Portfolios from 1 to 7, with 1 being the lowest, this fund is a 4.

The fund invests in a range of asset classes, that can include, but is not limited to equities, fixed interest, cash, property, and commodities.

Who is the fund designed for?

It is designed for someone who has a moderately cautious, balanced or moderately adventurous attitude to risk and is a medium time away from retirement. With this time horizon and attitude to risk, a medium level of investment risk is appropriate.


